1. JURISDICTION

This meeting will be promoted by the South Taranaki Car Club and will be held under these Supplementary Regulations, MotorSport New Zealand Inc National Sporting Code and its Appendices and Schedules. In particular, Appendix Five, Schedule C, and Appendix Two, Schedule A, "Driver and vehicle safety requirements" of the MotorSport New Zealand Manual.

This meeting will be organised under a MotorSport New Zealand **ClubSport Advanced Category Permit**. **PLEASE NOTE** This is not a "Drift" Event and NO DRIFT Demonstrations will be held.

3. EVENT DESCRIPTION

Date: Sunday 9th of August 2020
Time: Observation run starts 10.00am, last run finishes approximately 4.00pm
Venue: Orlando street, Stratford
Classes: The following classes will be observed for placings and club points: A = 0-1300, B = 1301-1600, C = 1601-2000, D = 2001+, E = 4 Wheel Drive, F = Classic (cars 25 years or older), G = Sports & Racing, H = Female Driver (3 or more entries).

- Turbo and Rotary equivalence factors will apply. *PLEASE INDICATE ON YOUR ENTRY FORM WHICH CLASS YOU ARE ENTERING*.
- The organisers retain the right to amalgamate, delete or reallocate any class and/or competitor

4. ENTRIES

Opening and closing dates: Entries open with the publication of these regulations and close at 5.00pm on **TUESDAY 4th AUGUST 2020.**

- Entries should be made through MotorSport NZ online at <u>www.online.motorsport.org.nz</u>.
- Organisers reserve the right to refuse any entry in accordance with the prescribed provisions of the National Sporting Code.
- Entries will be **deemed valid** only when payment is received, and **late entries** will be accepted upon receiving payment of the Late entry fee outlined below.
- NO ENTRIES WILL BE ACCEPTED ON THE DAY OF THE EVENT.
- Please advise the Secretary if the car is Dual entered.

Entry fees:Entry fee for all classes: \$ 75.00 including GST up until closing date 4th August 2020Late Entry Fee:\$110.00 including GST closing at 5.00pm, Friday 7th August 2020

Number of starters: The maximum number of entries will be 40. Any additional entries received will be placed on the reserve list in order of receipt.

5. COMPETITOR REQUIREMENTS and UNDERSTANDING

- Licence requirements: All drivers <u>must</u> hold as a minimum, an M Grade Competition Licence and a current club membership card for MotorSport NZ Affiliated Club.
- **Competitor understanding:** In submitting the entry, competitors are deemed to fully understand the MotorSport NZ National Sporting Code and its relevant Appendices and Schedules. In particular, The National Sporting Code Articles pertaining to protests and competitors' obligations, and Appendix Five, Schedule C.
- All Competitors **and** Passengers shall wear safety apparel in compliance with Appendix Two, Schedule A.
- All drivers and passengers must sign the indemnity on the entry form, and those under 16 years of age must have their entry form countersigned by their Parent/Guardian.
- Vehicle noise must not exceed 95db the Clerk of the Course will be the Judge of Fact.

6. ELIGIBLE VEHICLES

All vehicles shall comply with Appendix Five, Schedule C and Appendix Two, Schedule A of the **current MotorSport Manual** unless stated otherwise in these supplementary regulations.

7. DOCUMENTATION and SCRUTINEERING

- **Documentation** will take place at the caravan between **8.30am and 9.30am** on the day of the event. All competitors must report to the Meeting Secretary prior to scrutineering and present evidence of their: Driver's Civil Licence, Driver's Competition Licence, Current Club Membership, Logbook (if applicable). *Failure to provide these documents may result in exclusion from the event.*
- Scrutineering will occur after attending documentation. Each competitor must then present their vehicle to the Scrutineer. A scrutineering audit will be conducted between 8.45am and 9.30am on the day of the event. Documentation and Scrutineering must be completed prior to drivers briefing.
- 8. DRIVERS BRIEFING: attendance is <u>COMPULSORY</u>. A roll call will be held this will take place at 9.45am at the caravan. Any driver who is not in attendance at roll call will be disqualified from the meeting at the discretion of the Clerk of course

9. POSTPONEMENT/ CANCELLATION/ ABONDONMENT and ORGANISERS RIGHTS

In accordance with the National Sporting Code Article 13, the organisers reserve the right to postpone or cancel the event, or part thereof under the following circumstances:

• Cancellation of the meeting if less than 12 entries received by **Tuesday 4th August 2020**.

- Postponement if the weather conditions impose or the Stewards of the meeting require the meeting to be postponed or delayed for reasons of safety.
- In the event of the meeting or part thereof being cancelled or postponed, entry fees may be refunded at the discretion of the organising committee.

10. ACCETANCE OF ENTRY/ WITHDRAWAL FROM EVENT PRIOR TO START

Organisers reserve the right to refuse any entry in accordance with the prescribed provisions of the National Sporting Code. Entrants will be advised of the acceptance of their entry. If the Secretary is not notified **24 hours before the event**, after which **NO REFUND** will be given. If notified 80% of Entry Fee will be returned.

11. PASSENGERS

- Passengers may be carried, at the discretion of the Clerk of Course, provided the car is fitted with the following equipment (which must comply with the Safety Schedule contained in Appendix Five, Schedule C Article 6.2): Approved roll protection (that means Homologated), a passenger seat and approved passenger safety harness.
- Passengers will be required to wear: a protective helmet, protective overalls and footwear conforming to MSNZ specifications & standards.
- All passengers must sign an indemnity form before their run.
- Minimum age of any passenger is 12 years.
- Passengers may be changed between runs at the discretion of the Clerk of the Course

12. DIRECTIONS TO VENUE

Travelling from the North you will drive through Stratford and turn left at the second round-a-bout onto Fenton Street. Take the first right onto Juliet St, which becomes Celia St and then turn right onto Orlando St. Traveling from the South, turn right at the first round-a-bout and continue with above instructions. The Circuit is 1km in length. Each driver is timed over two laps and it is run in an anti-clockwise direction.

13. UNLOADING OF VEHICLES

Unloading of vehicles and parking will take place on Orlando Street, at The Hinton Contracting Yard by kind permission.

- 14. ALCOHOL Is strictly prohibited during the running of the event by any competitor or their crew.
- **15. FOOD** The Stratford High School Hockey Teams will be providing hot food along with cold & hot drinks. Your Support would be appreciated.

16. PRACTICE and RACING

- Competitors will be split into groups dual entries will be in separate groups, practice and racing will be run in these groups.
- Competitors <u>MUST</u> practice/complete in the order posted by the Event Committee and competitors <u>MUST</u> remain in this order throughout the meeting, unless exceptional circumstances prevail.
- Practice will commence at 10.00 am.
- There will be one practice and three official runs the Clerk of Course retains the right to decrease or increase the number of runs dependent on the road/weather conditions.
- Practice runs will not be recorded as an official run.
- 'Warm Up's' on any public open road is **PROHIBITED.**

17. STARTING PROCEDURE

Cars will be called to form IN THE ORDER GIVEN and each car will be called to the start line. Cars will be sent off at intervals. Identification of entrant/vehicle to the Starter is the responsibility of the competitor. Dual entries must also ensure they identify themselves to the Starter.

18. PROCEDURE AT CONCLUSION OF EACH RUN

At the conclusion of each run you are to make your way back to the pit area.

19. RE-SCRUTINEERING

Any vehicle involved in a collision or other accident may be required to be re-examined prior to continuing with competition, at the discretion of the Chief Scrutineer.

20. RETIREMENTS and WITHDRAWALS

Retirements and withdrawals must be notified without delay to the Event Secretary.

21. PROTESTS

If considered necessary, these should be lodged with the Clerk of Course in accordance with the current MotorSport NZ Manual.

22. VENUE DAMAGE

- In the event of any damage occurring to any part of the venue, this is to be reported immediately to the Clerk of Course or Event Secretary.
- Any costs associated with any damage will be incurred by the driver causing the damage. Including the specific "Safety Barriers" and cones which will be circulated around the track.

23. ACCESS TO PUBLIC

In the event of members of the public wanting access to the road, please direct them to the Clerk of Course, Caravan, or appropriate meeting official. Access is to be made available after clearance from event officials in line with safety procedures. There will be a **"Gold Coin' Donation** requested from walking Public wishing to view the event.

24. RUBBISH

All competitors, supporters and crew are asked to collect all rubbish and foreign objects in and around the venue on completion of the meeting, and take away with you. We need to leave this venue just as clean as we found it. **Please take ALL rubbish home with you!!!** Thank you, your co-operation appreciated.

25. PRIZEGIVING

Prizegiving will take place at the Clubrooms of Club X at 127 Cordelia Street at the conclusion of the meeting, once all areas are tidied and left as they were found. BBQ Food and Refreshments will be available to purchase.
